## ANNUAL AGREEMENT FOR MOORINGS ABOVE LOOE BRIDGE AND/OR DINGHY PARK

The annual charge for mooring space, rented moorings and wall fixing (where applicable), for each boat above Looe Bridge is renewable on the 1st April AND MUST BE PAID FOR BY THE 1<sup>ST</sup> MARCH 2010.

If payment is not received by the 1<sup>ST</sup> MARCH 2010, mooring spaces, rented moorings and wall fixings will be reallocated on the 1<sup>st</sup> April 2010. Any craft remaining after 1<sup>st</sup> April 2010 will be impounded to our lock up area and a daily charge of £8, plus labour, plus VAT will be made. The above charge is in addition to the annual mooring fees.

The annual and part annual charge for boats using rented moorings is £19.35<sup>#</sup> per foot (and part foot). MINIMUM CHARGE £232.40. The annual charge for tender up to a maximum 10 foot in length left on our dinghy park and the use of slipway is £90.00 (This includes the use of the slipway for customer's dinghies, the yard's dinghy trolleys but not yard's dinghies).

ALL MOORING CHARGES INCLUDE VAT at the current rate, No refunds will be made for moorings or wall fixings.

THESE CHARGES DO NOT INCLUDE PARKING TRAILERS AND/OR VEHICLES ON OUR PREMISES (WE OPERATE A PAY AND DISPLAY SYSTEM FOR THIS PURPOSE).

A returnable charge \*\*\* of £82.24 for cleaning each mooring will be made, your account will be credited with this amount. A charge of £20.13 will be made for each occasion your mooring has to be cleared by us. Any balance will be refunded at the beginning of December 2010.
